Once a Guardsman Always a Guardsman

Introduction

The term "Once a Guardsman Always a Guardsman" is often coined however many Guardsman fade off the radar of the Association when they no longer pay dues. The Regimental Association is the organization whose roll it is to maintain contact with and encourage all Guardsmen to remain affiliated with the greater Regimental family.

During the 21 March 2017 meeting of the executive, there was discussion on how to both increase the membership and simplify the administration of membership. It was felt that the paying of dues by non-serving members was an obstacle for many and was difficult to track, administer and collect dues.

Costs associated with membership dues were in large part used to cover postage for the Guards Star. As the Guards Star is for the most part distributed via email/ website, and most events are user pay the thought within the executive was that we eliminate dues for all past serving members and compensate for the loss in revenue by using other streams such as fundraising, voluntary donations and subscriptions for user pay events such as the Reunion Dinner and Guards Ball if need be.

Proposed Motions

Motion to amend Para 8 of the bylaws regarding Ordinary Members:

The current para 8.1 states "Ordinary membership is open to all persons serving, or who have served, with the Governor General's Foot Guards or other Guards Regiments"

Motion to strike this para and replace with:

8 Ordinary Members

8.1 Ordinary members comprise both Serving Members of the Governor General's Foot Guards, and Non-Serving Members of the Regimental Family.

8.2 Serving Members are those that are presently on strength of the Governor General's Foot Guards. Membership fees shall be assesses annually based on the parade state at the time of the AGM against the three rank based social clubs.

8.3 Non-Serving Members include all persons presently serving with other Guards Regiments, those who have served with the Governor General's Foot Guards or other Guards Regiments. Upon outclearance from the Regiment, members will transfer from the Serving Membership to the Non-Serving Membership role.

8.4 Application for non-serving membership shall be accompanied with evidence of qualifying service be either the applicant or their sponsor. Upon approval of the Executive Committee, their names shall be sent to the membership prior to the next General Meeting for approval. Upon approval, members shall be granted voting privileges

Seconded by:

Follow on Motion to amend Para 9 Life Members:

The current para 9.1 states "Life membership may be granted to a member of the Association on payment of a lump sum of money after having reached the age of sixty-five (65) years. Life Members granted by the GGFG Association (pre 2006) will be honoured with Life Memberships in the Regimental Association." As

only Serving Members will now be assessed dues, this para no longer is applicable.

Motion to amend Para 9 Life Members to read:

9. Life Members

9.1 Life Membership prior to 2017 was granted to a member of the Association on payment of a lump sum of money after having reached the age of sixty-five (65) years. As of 2017 membership fees were no longer assessed against

non-serving members and therefore all Life Members were transferred to the "Non-Serving Member" list annotated "Pre-2017 Life Member".

9.2 Life Membership dues paid prior to 2017 shall not be refunded, however pre-2017 "Life Members" may still retain the title and any associated benefits or privileges afforded to such members.

Motion to amend the By Laws of the Governor General's Foot Guards Regimental Association to more precisely define how the assets of the Association may be invested.

Amend Para 23 - Add Sub Para 23.1.7 - "Investment Committee"

New Para 30: Investment Committee

30.1 Purpose: To support the Regimental Association in generating a beneficial rate of return on assets for the purpose of supporting the good works of the Association and Regimental family.

Membership:

- i. Chair Honorary Lieutenant Colonel;
- ii. Member at Large Sentry Fund Representative;
- iii. Member at Large Association Member;
- iv. Member at Large Association CFO; and
- v. Regimental Member at Large Deputy Commanding Officer.

30.3 Included Assets:

- i. Assets of the Regimental Association General Funds as directed by the Executive;
- ii. The Legacy Fund;

iii. The Endowment Trust Fund (Sentry Fund); and

iv. 150th Anniversary Funds.

30.4 Investment Policy Statement

- (1) This Investment Policy Statement applies to the Governor General's Foot Guards Regimental Association. The purpose of the Statement is to outline the policy with respect to types and balance of investments that may be held within the Association investment accounts (including investments for the General Account). Funds may be invested in investments on offer by licensed financial institutions used by the Association. The allocation of funds among asset classes has the greatest role in determining investment returns. Establishing the asset class allocation ranges and policy neutral percentages for each asset class will have the greatest determinant effect on the investment returns over the long run.
- (2) Investment Committee. The Association Executive will form an Investment Committee consisting of the membership listed above to manage the investment accounts. The Investment Committee will instruct the Investment Advisor on the asset allocation of invested funds and will meet periodically to review and adjust holdings as necessary to achieve the investment objectives prescribed below. The Investment Committee will report to the Executive quarterly, and to the Association AGM annually on the performance of the investments and seek any
